HDC 17-26 – 15 West Main Street; Steamboat Wharf Company LLC, owner; James Verni, applicant; Signage. PIN #261918411742 0050

James Verni, presented to the Commission regarding signage for his store Trove located at 15 West Main Street, which is owned by Steamboat Wharf Company LLC. He is proposing to replace the existing bracket with a custom made steel, fixed bracket. The sign is round and will have black lettering on a white background.
