*Councilors received emails and communications regarding the referendum items that will be on the ballot in November, the Poquonnock Bridge Fire District, and an ordinance regarding chickens.*

*Councilors attended Groton's Fall Festival at Poquonnock Plains Park.*

*Councilor Flax attended a Trails Forum.*

*Councilor Flax and Councilor Watson reported on the Board of Education/Town Council/RTM/City Council Liaison Committee meeting.*

*Councilor Antipas attended the Annual Gala for the Mystic & Noank Library.*

*Councilor Schmidt noted that a Fitch High School Community Forum will be held on November 6, 2013, and a workshop on turnkey solutions that address municipal challenges will be held at Fairfield University on October 24, 2013.*

*Councilor Streeter noted that the Groton Rotary registered over 170 children as part of the Amber Alert program at Fall Festival. He announced that nearly \$18,000 has been raised so far for the Veterans Memorial Park and tiles will be available for purchase soon.*

*Mayor Somers, Councilor Streeter, Councilor Antipas, and Councilor Morton attended the Pirate Invasion in downtown Mystic. Councilor Morton noted that more police coverage was needed due to the volume of people attending the event.*

*Mayor Somers attended the Community Garden Forum at Mary Morrison Elementary School. She noted that the Noank Rowing Club will hold a spaghetti dinner on October 18, 2013; the annual fundraiser for Riverfront Children's Center will be held on October 19, 2013.*
